


Hardware Overview




- 1 Bracket

Mount the product in a rack




- 1. Attach the mounting brackets to both sides of the chassi. Insert screws and tighten then with a screwdriver to secure the brackets.
- 2. Place the product on a rack shelf in the rack. Push it in until the oval holes in the brackets align with the mounting holes in the rack posts.



3. Attach the brackets to the posts. Insert screws and tighten them.

Mount the product on a desk or shelf

1. Verify that the workbench is sturdy and reliably grounded.



2. Attach the four adhesive rubber feet to the bottom of the product.

Installation steps

- 1. Connect a standard network cable to RJ45 port 17 or 18 on the product.
- 2. Connect the other end of the cable to a computer.
- 3. Connect the power cord to the product.
- Connect the other end of the power cord to a standard AC outlet. The System LED lights up and confirms that the device is powered up successfully.
- 5. Use AXIS IP Utility or AXIS Camera Management to find the product on your network.
- 6. Use the username and password on the product label to enter the product.
- 7. Follow the instructions on the screen.

Important

Use only the supplied power cord to power the product.

Note

For security purposes, it is recommended to change the default password.

Install SFP Modules

You can install or remove a mini-GBIC SFP module from a SFP slot without having to power off the product. The SFP slots 17–18 are shared with the RJ-45 ports 17–18.

Important

If a mini-GBIC is installed in slot 17-18, the associated RJ-45 port 17-18 is disabled and cannot be used. Make sure the network cable is not connected to RJ-45 port 17-18 when you install or remove a mini-GBIC.

- 1. Insert the module into the SFP slot.
- 2. Press firmly to ensure that the module seats into the connector.

Power notice

The product is a power-required device, meaning it will not work until it is powered. Consider using an UPS (Uninterupted Power Supply) in order to avoid network data loss or network downtime.

Installing a surge suppression device may also help to protect the product from being damaged by unregulated surge or current to the product or the power cord.

How to use the Mode/Reset button

By pressing the Mode/Reset button for certain period of time, users can perform the following tasks.

- Change between port status mode Link/Act/Speed and PoE.
- Reset the product to the previous configuration settings saved.
- Restore the product to the original factory default settings.

Change port status mode between Link/Act/Speed and PoE	0-2 seconds	Green (lit)	LED status changes according to the selected mode.
Reset the product	2-7 seconds	Green (blink)	The lights are OFF for all LEDs
Restore to the original factory default settings	7-12 seconds	Green (blink)	The lights are ON for all LEDs

PoE	Green (lit)	The RJ45 Port Status LEDs are displaying PoE powering status of each port.

By pressing the Mode/Reset button in less than 2 seconds to change LED modes (Link/Act/Speed Mode or PoE Mode), users can check the port status by reading the LED behaviors in the tables below.
